The Festival Committee makes every effort possible, from the information you provide to us, not to have an overabundance of the same item; however, we cannot guarantee there will not be duplications. All applications received are reviewed by the Sunflower Festival Committee.

Statham Sunflower Festival Committee reserves the right to prohibit the use, possession or sale of any item it determines to be detrimental to the health, safety, or well being of any person. Prohibited items include, but are not limited to alcohol, tobacco, knives, all contraband, pyrotechnical items, all firearms, and all items realistically resembling firearms.

**ALL FOOD VENDORS ARE TO HAVE CURRENT DATED FIRE EXTINGUISHERS
(5 LB. MINIMUM)**

All booths will be on asphalt and no spikes are allowed to be driven into the asphalt. There is no water connection available. You will be responsible for installing your own booth by 8:00 a.m. and for removing same at 5:00 p.m.

Stham Sunflower Festival will not be responsible for any personal property damage or theft as a result of the festival. The exhibitor hereby agrees that the premises are to be used and enjoyed at the sole risk of the exhibitor and further releases and agrees to hold harmless the Stham Sunflower Festival, its Committee, City of Stham and Barrow County against all liabilities, damage cost, fees and expenses, causes or action suits, demands, judgments and claims of any nature whatsoever arising from, by any reason of, or in connection with injury to or death of persons, or damage to property from a condition on the premises. A signed application constitutes a contract to follow all rules and regulations and is a commitment to participate if accepted. Violations of rules and regulations will result in the closing of the exhibitor's booth for the duration of the show without refund and the exhibitor will be excluded from future festivals. All trash and debris must be removed from your booth area, and the area left in the same condition as it was prior to festival day.
