3. 2nd Reading of Home Rule Amendment- Planning Director

E. NEW BUSINESS:

1. Code Enforcement/Bureau Veritas/Police Dept.- Dwight McCormic

Dwight McCormic stated his opinion about the Mayor putting employment ad for CE & PO in the paper. Mayor was within his rights, but Dwight McCormic felt that since Council had already voted down replacing Bureau Veritas, he felt the Mayor had let down the citizens of Statham. Mayor responded by saying we would keep Bureau Veritas until Council changed it.

2. Jackson County Inmate Work Detail

Comparison between inmate program we have now and Jackson County Inmate Program. Perry Barton made motion to approve. No second was given. No vote taken. Motion failed.

3. RFP for Audit Services

Council went over the cost again in comparison with the two companies, Bates & Carter and Rushton. Dwight McCormic made a motion to accept Bates & Carter for the FY2017 audit. Betty seconded, 4/4.

4. Options on Purchasing Wholesale Water

Mai Chang spoke about the cost we are paying for Barrow County Water. She ask for a motion from Council to authorize the Mayor to authorize City Hall staff to start negotiating for lower water prices. Hattie Thrasher made a motion to approve. Betty Lyle seconded, 4/4.

5. 1st Reading of Small Cell Ordinance-Permitting Department

City Attorney Thomas Mitchell spoke briefly about this ordinance and then recommended Council to waive 1st reading. Perry Barton made motion to waive 1st reading of Small Cell Ordinance. Betty Lyle seconded, 4/4.

6. Easement

City Attorney Thomas Mitchell spoke about how the sewer system goes across Ms. Lyle's yard on Second Street, because back in the 1960's & 1970's that's the way it was done. It was designed by, approved by and maintained by the City of Statham. Ms. Lyle decided the right thing to do is to signed that sewer easement to the city. Perry Barton made a motion to approve easement. Dwight McCormic seconded. Motion passed, 3/1. Betty Lyle abstained.

7. Resolution for Special Called Election

City Attorney Thomas Mitchell spoke about Mr. Jackson's resignation and the Special Election that is to take place at the same time as the General Election to filled the remainder of his term, which is two years. Perry Barton made motion to approve. Betty Lyle seconded, 4/4.

F. CITIZENS CONCERNS:

1. Joe Piper- Code Enforcement/Citizens Trust

Mr. Piper just thanked the Mayor for making what he felt was the right decision to keep the Code Enforcement we already have.

2. Catherine Corkren- Public Corruption

Ms. Corkren spoke about the demands Ms. Lyle has put on the city to replace faulty sewer line on Ms.Lyles property. Ms. Lyle responded to let her know she did not demand city to do the work. She explained that the sewer line was there before she ever moved into the house (work done by city in 1960's). She explained it is not a service line, it is a collection line.

3. Michael Gentry of Ashley Meadows HOA- Water Quality Concerns

He is concerned that the water smells bad. He ask Jordan McDaniel a few questions about the testing of the water and if parts had been replaced and if we are compliant now. Jordan answered all his questions and Perry Barton explained why he had the smell from time to time having to do with the resevior being on 6'deep and the challenges to keep from not having the odor.
